**WALK-THROUGH SCHEDULE:** Walk-throughs will likely follow this pattern (but is subject to change):

ALL Novice, Open, T2B, and Premier height classes will walk together.

All FAST classes will walk together in 1 walk-through prior to starting. The classes will then run consecutively.

**Sunday: Walk 4-12, Run 4-12; Walk 16, Run 16; Walk 20-24C; Run 20-24C**

**Camping:** If you have paid for camping, you MUST pick up a camping permit from the trial secretary or the Fairgrounds. If you would like to camp, you can still sign up for it at the show on a first come, first serve basis.

**Quiet Hours** are from 10 pm to 6 am. No generators during that time. Please be considerate of your fellow campers!

**Height Measurements:** If you have not been measured, you must do so before you run. Lori Sage is a Voluntary Measuring Official (VMO) and exhibitor Paula Ratoza is also a VMO. Lori will be available all 3 days and Paula on Sat/Sun to provide permanent height measurements. If you need to be measured, we will have a judge available near the score table office from about 8am to 9am Friday morning, about 7am to 8am Saturday and Sunday mornings, and then as time allows. If you have any questions, please ask!

**Move-ups:** The deadline to send in move-ups is Sept 17, 2018 at 6 pm. You must notify me in writing – email is ok. Move-ups for Saturday and Sunday are allowed and forms will be provided.

**Help Wanted!** As you know, shows could not run without the generosity of our fellow competitors! We will insure that your working does NOT interfere with a walk through or running a course. You will be provided with a coupon good for lunch, vendors, or future entries. We are using a white board for worker sign ups.

**Food:** Sweet Al's will be the food vender on site. There are other food places within a few miles of the site.
