## **Start times:**

Saturday: First dog on line at 8:30 am in Ring 1. Ring 2 starts about 30 minutes later with first dog on line.

Ring 2: Tracy Mazur: Ex/Mas Fast, Open Fast, Novice Fast, Novice JWW, Open JWW, Ex/Mas JWW, Premier JWW

**WALK-THROUGH SCHEDULE:** Walk-throughs will likely follow this pattern (but is subject to change):

ALL Novice, Open, T2B, and Premier height classes will walk together.

All FAST classes will walk together in 1 walk-through prior to starting, then all classes will run together by height.

## **EX/MAS JWW and EX/MAS STD**

**Friday and Sunday: Walk 4-16, Run 4-16; Walk 20-24C, Run 20-24C**

**Saturday: Walk 24C-24, Run 24C-24, Walk 20, Run 20; Walk 16, Run 16; Walk 12-4; Run 12-4**

**Camping:** If you have paid for camping, you MUST pick up a camping permit from the trial secretary or the Fairgrounds. If you would like to camp, you can still sign up for it at the show on a first come, first serve basis.

**Quiet Hours** are from 10 pm to 6 am. No generators during that time. Please be considerate of your fellow campers!

**Height Measurements:** If you have not been measured, you must do so before you run. Paula Ratoza is a Voluntary Measuring Official (VMO). She will be available all 3 days to provide permanent height measurements. If you need to be measured, there will be forms and wicket outside the score table office. Measurements will be from about 8:30am to 9am Friday morning, about 8am to 8:30am Saturday and Sunday mornings, and then as time allows. If you have any questions, please ask!

**Move-ups:** The deadline to send in move-ups is March 11, 2019 at 6 pm. You must notify me in writing – email is ok. Move-ups for Saturday and Sunday are allowed and forms will be provided.

**Help Wanted!** As you know, shows could not run without the generosity of our fellow competitors! We will insure that your working does NOT interfere with a walk through or running a course. You will be provided with a coupon good for lunch, vendors, or future entries. We are using a white board for worker sign ups.

**Food:** Sweet Al's will be the food vender on site. There are other food places within a few miles of the site.

**B MATCH!!!** We will have a B match on Saturday about 30 minutes after the last run of the day. Cost is \$5 per 90 seconds in the ring. You can sign up for the match near where the ribbons are located and you can do up to a maximum of 2 runs per ring. One ring will be setup for Jumpers with Weaves and the other will be Standard. No food permitted but toys are allowed. So come and have fun with your dog and get a little practice in!

### **RAFFLES!!!**

PAC will hold a Special raffle for workers (blankets to be the prize) as there will be no 4-H workers at this trial since on Friday and Sunday there should be no conflicts as there is just one judge. Please work as often as possible to give you more chances at winning a blanket ☺

Also, since Saturday is our two judge trial, we will be raffling off a chance for a blanket for anyone wearing green in honor of St. Patrick's Day.

**Site Info:** This trial will be held in 2 rings indoors on packed dirt. Please bring chairs, crates, and clean up tools for your dogs. The trial site will be available for set up on Thursday from 3 pm to dusk. The club reserves the right to move set-ups, without notice, if space is needed for trial administration use. There is no charge for entering the fairgrounds to set up or for day-of-show parking.

**Directions to the Trial Site:** From North or South-bound I-5, take Exit #9 (in Washington), head west on 179th for 0.5 miles, turn left onto 2nd Avenue, then left again at the Purple Gate. The Equestrian Bldg. is on the right, at the end of the road.
